From City Manager James L. Gillis, Jr.:

Following the devastating effects of Hurricane Milton which surpassed our stormwater capabilities, we have made the commitment to improve our system to better accommodate this new breed of storms and the flooding rains they produce. The City has hired a drainage engineering firm to model our existing stormwater system. This model can be used to recreate the flood and identify the weaknesses in our system. A series of stormwater improvements will then be developed for the City to implement with the main goal of keeping floodwaters out of homes.

We have made the drainage engineers available at the Piggotte Community Center to those who experienced flooding in their homes. The first of these events were well attended and the drainage engineers received valuable information. A second opportunity to meet with the drainage engineers will be held on Tuesday, January 7, 2025, from 12pm until 8pm. To reduce wait times, this event is by appointment only so please contact the City Manager's office at (386) 322-3014 to reserve your spot. The engineers will be looking for information on the height of the floodwaters in your home and any pictures you have which will all be incorporated in the study being conducted.

In response to the flooding experienced by Hurricane Ian in 2022, the City applied for four large-scale grants with Volusia County as a part of their Community Development Block Grant – Disaster Recovery (CDBG-DR) program. Those four projects are the Lantern Park Stormwater Improvements, Sherwood Forest Stormwater Pond, Aspen Stormwater Pond Expansion, and Stevens Canal Bank Stabilization to enhance our stormwater system.

The Lantern Park Stormwater Improvements involve the acquisition of vacant land and the construction of stormwater pond(s) and pump station(s) with permanently housed generator(s) designed to help alleviate flooding within the subdivision.

The Sherwood Forest Stormwater Pond project involves the acquisition of homes in order to construct a stormwater pond with a pump station with a permanently housed generator designed to help alleviate flooding within the subdivision.

The Aspen Stormwater Pond Expansion project involves vastly increasing the size of the existing pond on Aspen Drive and increasing the pump station capacity there to help alleviate flooding within the Big Tree Village subdivision.

The Stevens Canal Bank Stabilization project involves the installation of sheet piling to widen and add more height to the bank to promote greater flow and storage in this canal. The completion of this project will help alleviate flooding within the back portion of the Big Tree Village subdivision as well as those homes located in the central portion of the City.

These grants total almost \$8 million and will greatly improve our stormwater capabilities in these vulnerable subdivisions. These grant funds will be disbursed on a reimbursement basis which means the City must have the cash on-hand to complete these projects. If the City was not debt-free with healthy reserves, we would not be able to apply for these large-scale projects. Having proved to the County that we have our finances in order, the City was extremely successful in securing these grant opportunities. We want to thank the Volusia County Council and staff for their partnership in improving the stormwater system here in South Daytona.

At the December Meeting, the City Council approved the purchase of four permanently housed generators to be installed at some of our larger stormwater stations. Those stations are located at the Lantern Park Stormwater Pond, Windle Lane Stormwater Pond, Reed Canal Park Stormwater Pond and Park of Honor. When we experience a power outage, we must dispatch portable generators to these pumps to keep them running. This is often done during the storm in dangerous conditions and may take as long 30 minutes to get properly setup. When experiencing a flooding rain event, every minute counts so having a permanent generator onsite will ensure the pump continues to run in a power outage without missing a beat. Our largest stormwater stations such as the one on Aspen and at the Reed Canal Stormwater Control Facility already have permanent generators stationed there and with the addition of these four new ones, we will be better prepared for power outages during a storm. When speaking with those residents who experienced home flooding, a statement we kept hearing is that they love South Daytona and do not want to move. We love South Daytona too and you have our commitment that we will make our stormwater system better.



Evaluation of the City's Drainage System

The City will be holding a second session for residents to provide information and insights to our Engineers for the evaluation of our drainage system.

This next session will be held on Tuesday, January 7, 2025 by appointment only (12:00 pm to 8:00 pm).

The first session was held on December 3, 2024. With almost 90 residents in attendance, the City scheduled a second session.
